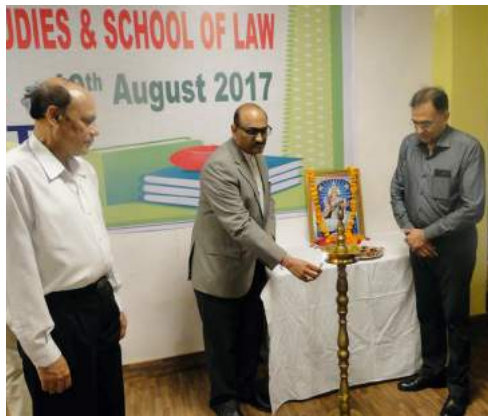

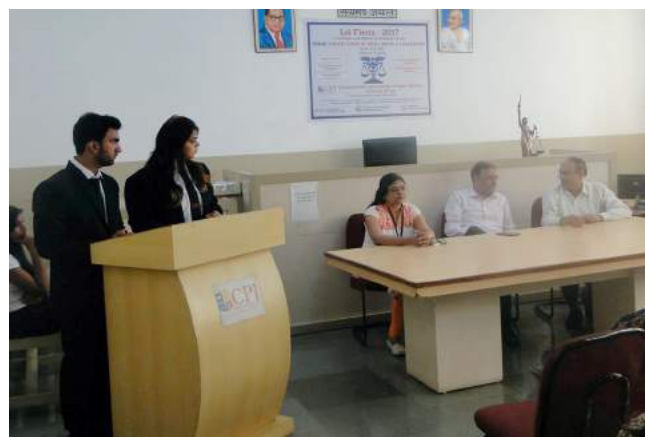
Learning & Entrainment Together at Movie Screening on 18th Aug, 2017

The third session of Central Legislative Assembly was held in this house on 19 January 1927.

The Parliament is bicameral with two houses: the Rajya Sabha (Council of States) and the Lok Sabha (House of the People). The President in his role as head of legislature has full powers to summon and prorogue either house of Parliament or to dissolve Lok Sabha. The president can exercise these powers only upon the advice of the Prime Minister and his Union Council of Ministers.

Students were motivated to learn in detail about, the highest constitutional body of over country & enriched them with good knowledge & awareness.

Tihar Jail Visit

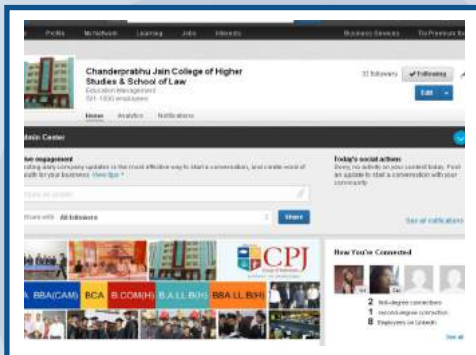

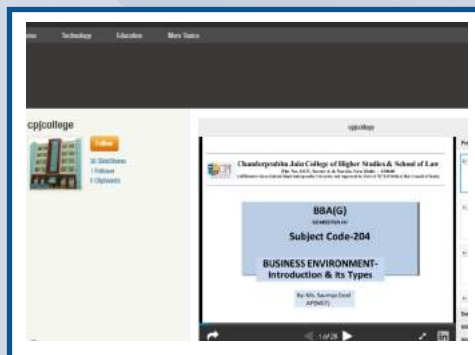



HADOOP TECHNOLOGY

Technology is increasing day by day. We can't even imagine the growth of technology in past 10 years. If we talk about smart phones, it would be difficult for us to digest in early 90's that one day we all will be having a device from which we can complete our work just by tapping.

Either it's about social networking, playing games, having video conferences and much more are now possible with our smart phones. But yes, when we talk about the latest technologies, developers have to think about its security, maintenance, modification and other parameters on which these technologies are designed. So, earlier when these software were designed, there were very less problem with memory. Now, each and every application, businesses all are now in mobility form. Due to which, keeping these values saved in a system is now becoming difficult to handle. So, to handle such a heavy amount of data; developers have created a new tech called **HADOOP TECHNOLOGY**. It is a part of apache project. Hadoop is open source java based framework that supports extreme large data set or values in distributed computing environment. Hadoop made it possible to handle **THOUSANDS OF TERABYTES OF DATA**.

Hadoop was created by computer scientists Doug Cutting and Mike Cafarella in 2006 to support distribution for the Nutch search engine. Hadoop1.0 became publically available in nov'12 as part of **apache project** sponsored by **apache foundation**. But, here a question arises that how Hadoop helps to manage such a bug amount of data. Part of hadoop's allure is that it consists of a variety of open source software components and associated tools for capturing, processing, managing and analyzing data. It works with clusters of online servers, so it is not used for the online transaction processing applications. When combined with combination of data and computing nodes, hadoop becomes massively parallel processing platform that suited to batch processing application for analyzing data.

Why to use hadoop? What are its advantages? Let's have a look upon it. One of the important characteristic is the, ingestion and processing up of large data sets, massive data volumes, and streaming data. Secondly, it consists the mixture of structured and unstructured data. Any type of data can be stored for example simple data or storing some server log files. Anything can be stored using hadoop. And last but not the least, it is cost efficient. Other than paying huge amount of money to high-end servers, the system architect believe that acceptable performance can be achieved by using commodity components.

So, this was brief about hadoop technology that made easy to secure your information more precisely with all of your data. Usage of hadoop technology is commonly used by facebook, twitter for handling the data more precisely.

SOPHIA THE ARTIFICIAL INTELLIGENCE

This is the human future. Sophia is a humanoid robot developed by Hong Kong-based company Hanson Robotics. She has been designed to learn and adapt to human behavior and work with humans, and has been interviewed around the world. In October 2017, she became a Saudi Arabian citizen, the first robot to receive citizenship in the country. Sophia was activated on April 19, 2015. She is modeled after actress Audrey Hepburn, and is known for her human-like appearance and behavior compared to previous robotic variants.

According to the manufacturer, David Hanson, Sophia has artificial intelligence, visual data processing and facial recognition. Sophia also imitates human gestures and facial expressions and is able to answer certain questions and to make simple conversations on predefined topics (e.g. on the

weather). The robot uses voice recognition technology from Alphabet Inc. (parent company of Google) and is designed to get smarter over time. Sophia's intelligence software is designed by Singularity NET. The AI program analyses conversations and extracts data that allows her to improve responses in the future. It is conceptually similar to the computer program ELIZA, which was one of the first attempts at simulating a human conversation. Hanson designed Sophia to be a suitable companion for the elderly at nursing homes, or to help crowds at large events or parks. He hopes that she can ultimately interact with other humans sufficiently to gain social skills

JOURNEY FROM SHAH BANO TO SHAYARA BANO

Triple Talaq, also known as Talaq-E-Biddat, instant divorce is a form of divorce in Islam. It allowed any Muslim man to legally divorce his wife with uttering the word Talaq (the Arabic word of divorce) three times in oral, written or more recently electric form. Its practice among Muslims in India has been a subject of controversy & debate from the last few decades. Those questioning the practice have raised issues of justice, gender, equality, human rights & secularism. This debate has evolved the government of India & supreme court of India and is connected to the debate about the uniform civil code to be enacted in India. On August 22, 2017 the honourable supreme court deemed instant Triple Talaq unconstitutional. In the case of Mohd. Ahmed Khan vs. Shah Bano Begum commonly referred to as Shah Bano case, was a controversial maintenance law suit in India, in which the supreme court delivered a judgement favouring maintenance given to an aggrieved divorced Muslim woman. In the case Shah bano, a 62 year old Muslim mother of five children from Indore was divorced by her husband in 1978. She filed a criminal suit in the Supreme Court of India and in which she won the right to maintenance from her husband. However, the Muslim politicians started a campaign for the nullification of the decision of the Honourable Supreme Court.

The main aim of the Shah Bano case's verdict was to provide maintenance to the Muslim women after the Talaq-e-Biddat by her husband but in the recent case of Shayara Bano vs. Union of India and others, the Honourable Supreme Court had kicked out this practice and declared it unconstitutional. In the Shayara Bano case the petitioner Shayara Bano approached the court, for assailing the divorce pronounced by her husband – Rizwan Ahmed on 10.10.2015, wherein he affirmed, in the

presence of willingness saying that he gave, “talaq, talaq, talaq”, hence like this he divorced his wife. From that point of time when he uttered talaq three times there is no relation of husband and wife. After reading separate judgements, the 5-judge bench of the Supreme Court ruled in the 3:2 majority that triple talaq is void and unconstitutional. CJI. Justice S. Khehar and Justice Nazeer said that it is a fundamental right while the 3 other judges – Justice Kurian Joseph, Justice R.F. Nariman and Justice U.V. Lalit- said it is not to as a fundamental right and said this practice void, illegal and unconstitutional.

GST

GST, Goods Services Tax which was passed in Lok Sabha on 29th march, 2017 and came into effect from 1st July 2017. The GST Act has totally revolutionized the Indian economy. Goods and Services Tax law in India is a comprehensive, multi stage, destination based tax that will be derived on every value addition, if said in simple words GST is an indirect tax levied on the supply of goods and services. GST is governed by a GST council and its chairman is the finance minister of India. GST has 3 components in it which are CGST (collected by central government on an interstate sale), SGST (collected by state government on an intra state sale), IGST (collected by central government for inter state sale).

GST removes cascading tax effect higher threshold for registration benefit people as prices will come lower which in turn will help companies as consumption will increase in GST system but on other hand it would also impact negatively on real estate market as it would add 8% to the cost of new houses and reduce demand by 12%. GST rates on goods and services have been broadly classified into four taxes rates: 5%, 12%, 18% and 28%. Some goods and services would exempt.

Under this law businesses are required to file returns each month. All administrative control of 90% of taxpayers having turnover below 1.5 crores would vest with state tax administrative while 10% with the central tax administrative and having turnover above 1.5 crores will be divided equally between central and state administrative. GST will be levied only at the final destination of consumption based on vat principle and not on various point and this will help in removing economic distortion and bring development of a common national market.

Goods and Services Tax (GST) is the biggest reform in India's indirect tax structure since the economy began to be opened up 25 years ago, at last looks set to began reality.

Right to Privacy Violated- Aadhaar Card

A few days ago the Supreme Court delivered its first verdict in a series of legal challenges against the Aadhaar project. In the present matter, the court was examining whether a provision of the Finance Act, 2017 that makes Aadhaar mandatory for filing of income tax returns and applying for Permanent Account Number (PAN) cards was constitutionally valid. The court has upheld the validity of this provision, subject to a few qualifications.

The Supreme Court delivered its judgment in the constitutional challenge to Section 139AA of the Income Tax Act, which was brought in by way of an amendment in April this year, this provision made it mandatory for all taxpayers to quote their Aadhaar number when applying for a Permanent Account Number (PAN) and for filing returns of income. Failure to link one's PAN with Aadhaar would automatically invalidate the former.

It has been argued that the collection of identity data without adequate safeguards interferes with the fundamental right to privacy protected under Article 21 of the Constitution. Article 21 guarantees right to life and personal liberty. In August 2015, a three judge bench of the Supreme Court passed an order stating that a larger bench must be formed to decide the questions of: (i) whether right to privacy is a fundamental right, and (ii) whether Aadhaar violates this right. However, the court has not set up a larger bench to hear these petitions till June 2017.

Another question before the court is whether Aadhaar can be made mandatory for those government benefits and services that citizens are entitled to under law. In 2015, the Supreme Court passed some interim orders stating that:

- (i) Aadhaar cannot be made mandatory for providing citizens with benefits and entitlements, and
- (ii) it can only be used for seven schemes including PDS distribution of food-grains and kerosene, LPG distribution scheme, MGNREGA wage payments, and Prime Minister's Jan Dhan Yojana.

Subsequently, Parliament enacted the Aadhaar Act, 2016, and the government has been issuing notifications under it to make Aadhaar mandatory for various schemes. In light of this, more petitions have been filed challenging these notifications. Judgements on these petitions are awaited as well.

The Supreme Court has held that the new provision of the

Income Tax Act that makes Aadhaar mandatory for income tax assesses is not in violation of the fundamental right to equality, or the fundamental right to practice one's profession or trade. The petitioner had contended that Aadhaar could not address the problem of tax fraud through duplicate PANs because there was evidence to show that people had multiple Aadhaar numbers as well but it has been rejected with a statement that Aadhaar is perceived as the best method of eliminating duplicate PANs, and therefore there is reasonable rationale behind linking the PAN database with Aadhaar.

As a result, the court decided not to examine questions related to human dignity and privacy, on the ground that issues affecting Article 21 will be examined by a larger bench to be set up by the court. However, it granted relief to people, who have not enrolled for Aadhaar, by stating that their PAN cards cannot be invalidated till the time when the matter is finally decided by such a bench.

In the context of the Aadhaar-PAN petitions, the pending reference on the issue of privacy is important as it severely curtails the ground for challenge available to the petitioners. Forced to give up arguments on privacy, the submissions in this case were largely limited to the issue of bodily integrity and the right to equality. Arguments were also made on the grounds that the introduction of Section 139AA of the Income tax Act violates Articles 14 and 19 of the Constitution of India.

However, in the present judgement, the Court has construed privacy broadly. The Court excluded all arguments made on bodily integrity, dignity and the right to informational self-determination, on the basis that these concepts linked to privacy.

PUBLIC INTEREST LITIGATION

In Indian law, **Public Interest Litigation** means litigation for the protection of the public interest. It is litigation introduced in a court of law, not by the aggrieved party but by the court itself or by any other private party. It is not necessary, for the exercise of the court's jurisdiction, that the person who is the victim of the violation of his or her right should personally approach the court.

Public interest litigation is the power given to the public by courts through judicial activism. However, the person filing the petition must prove to the satisfaction of the court that the petition is being filed for a public interest and not just as a frivolous litigation by a busy body.

The seeds of the concept of public interest litigation were initially sown in India by Krishna Iyer J., in 1976 in **Mumbai Kamagar Sabha vs. Abdul Thai**. Such cases may occur when the victim does not have the necessary resources to commence litigation or his freedom to move court has been suppressed or encroached upon.

The court can itself take cognizance of the matter and proceed *suo motu* or cases can commence on the petition of any public-spirited individual. Public interest litigation or social interest litigation today has great significance and drew the attention of all concerned.

The traditional rule of "Locus Standi" that a person, whose right is infringed alone can file a petition, has been considerably relaxed by the Supreme Court in its recent decisions. Now, the court permits public interest litigation at the instance of public spirited citizens for the enforcement of constitutional o- legal rights.

Now, any public spirited citizen can move/approach the court for the public cause by filing a petition. It is boon in the history of the judicial system of the country as in Public Interest Litigation (PIL) vigilant citizens of the country can find an inexpensive legal remedy because there is only a nominal fixed court fee involved in this.

Moreover, through the so-called PIL the litigants can focus attention on and achieve results pertaining to larger public issues, especially in the fields of human rights, consumer welfare and environment.

Even though it is very much essential to curb the misuse and abuse of PIL, any move by the government to regulate the PIL results in widespread protests from those who are not aware of its abuse and equate any form of regulation with erosion of their fundamental rights.

Under these circumstances the Supreme Court of India is required to step in by incorporating safe guards provided by the civil procedure code in matters of stay orders /injunctions in the arena of PIL. However, bona fide litigants of India have nothing to fear.

Only those PIL activists who prefer to file frivolous complaints will have to pay compensation to then opposite parties. It is actually a welcome move because no one in the country can deny that even PIL activists should be responsible and accountable.
