Guidelines for Internal Examination

- **1.** The Time Duration is **2 hours** for completion of the Exam. Non Attendance due to any circumstances will also be treated as absent.
- **2.** The Question Paper consists of Questions from all three units, which are divided into two parts: **Part A** contains mixed questions with 6 subparts of 2.5 marks each with an option to attempt any 4 sub parts—(Total 10 marks), **Part B** contains 5 questions in total out of which any 3 can be attempted-(Total Marks-30).
- **3.** Students need to report to their respective Examination Classrooms as per the seating plan, 15 minutes prior to commencement of the examination. No student shall be allowed to enter after 30 minutes after the commencement of examination.
- **4.** The Students are required to write the complete details on the first page of answer script as well as Enrollment no. on Question paper
- **5.** In case of any problem during the examination, the students need to report the issue to the Respective Invigilator Present in the classroom.
