#### Greetings from Chanderprabhu Jain College of Higher Studies & School of Law!!

All students of **BBA** (**G**) | **BBA** (**CAM**) | **B.COM** (**H**) | **BCA** to note that in view of Commencement of **Even Semester w.e.f. 01-February-2024**, physical attendance is mandatory for all for attending the classes & other academic activities. As such, a strict vigil shall be observed by the concerned college authorities to regulate proper discipline amongst all the students & the following points needs to be strictly observed for maintaining proper discipline and code of conduct -

**Time Table** of respective courses shall be notified soon and it is important to note that the last lecture for the day shall suspend at <u>3:00 PM and departure of buses</u> @ <u>3:15 PM</u>. However, students commuting on their own and wishing to stay back for Library / Computer Lab facility need to note that same shall remain operational till 5:00 PM.

- **4** Students must carry their **ID Cards/ Library Cards** for gaining entry into the College Campus.
- All students must be **formally dressed** and maintain proper **code of conduct & discipline** & need to **carry their ID Card/ Library Card** for gaining entry into the college campus.
